1. What is the purpose of the study?

- Reconceptualise the CER framework based on implementation at six higher education providers, to ensure alignment with the TEQSA Guidance Note: Scholarship
- Address barriers to uptake and address identified opportunities and strategic actions that will support institutions to incorporate scholarship into their infrastructure for learning and teaching
- Extend and contextualise the CER STEM framework in at least six Science (or Allied) Faculties/Colleges in Australian universities
- Build on national and international networks and partnerships to promote best practice in learning and teaching.

2. Why have I been invited to participate in the study?

3. How is the study being funded?

The Fellowship is funded by the Australian Council of Deans of Science and the University of Tasmania.

4. What does the study involve?

Our Fellowship will conceptualise leadership for active engagement in scholarship within teaching teams. It includes a CER STEM framework to ensure team-based scholarship activities are aligned with institutional structures, processes and instruments, so that scholarship can be focussed on degree-level curriculum and can be made visible, monitored, measured and reported against TEQSA standards.

5. What will I be asked to do?

You will be asked to complete an online survey. The survey questions are for you to provide feedback and comments after participating in a CER-STEM framework dissemination activity, for example listening to a presentation (face to face or online) of the CER-STEM framework and/or participating in a workshop (face to face or online).

Online participation: By completing the online survey, you are implying consent to participate in this study, acknowledging that participation is voluntary and that you have read this information sheet.

9. What will happen to the data when this study is over?

All information will be treated in a confidential manner, and your name will not be used in any publication arising out of the research. All the research will be kept in a locked cabinet in the Project Office at the University of Tasmania. The data will be destroyed via secure disposal five years after the last publication from the research.
