## 1. Unis are failing employers, job tsar warns

The Australian, Wednesday 23 July 2025

Job Skills Australia is reported as saying that universities are failing to produce work-ready graduates. Graduates lack hands-on experience, cannot communicate clearly or work in a team. While Engineering and IT are mentioned, it seems from their research that the biggest problem is in finding the right people for technical and trade jobs. For me, this means we need to support the value of TAFE and vocational education.

• This is a global survey which includes about 800 Australian people born between 1983 and 2006. The report suggests that globally these people are facing economic pressures (so financial security is important), they are grappling with rapid technological change (including AI) and they want employers to do more for them (to help them learn and develop, to provide meaningful work and wellbeing). They also question (globally) the value of higher education – perhaps vocational training is more important in providing practical skills. However their main criticism is simply the cost of a university degree.

• This is a series of four very brief reports. The first two have been published. They argue that 'more than a dozen [government] portfolios are involved in running over a hundred different research programs often with no shared strategy, no consistent approach and no clear way to align efforts'. The solution: consolidate programs, create a Ministerial Research Council, raise public R&D investment in research.

#### 6. Incentivising business investment in R&D

• The Academy proposes incentivising R&D investment by essentially applying a levy to large businesses who don't invest in R&D. There is detail in their document to show how this could be used to benefit businesses, researchers and the economy. They show that Australia sits well below the average OECD investment by the business sector and they argue that this threatens our productivity and our standard of living.

• This paper summarises initial conclusions from the panel's analysis of over 600 submissions. Australia needs to facilitate collaboration and alignment between the many funding programs, have targeted incentives for innovation and investment, and focus on the impact of research. Fundamental research is important but we must create value from our investments. They talk about the importance of research, development and innovation (where innovation means commercialisation or end-user impact). R&D is a long-term endeavour. They say they will release various issues papers in coming months.

#### 8. Australia's Higher Education sector faces a financial and strategic reset

• KordaMentha is an Australian advisory and investment firm. They have analysed 30 Australian university annual reports and the results of a national survey of university COOs and CFOs. They say that overall debt has increased, cash reserves have fallen and 20 universities report more liabilities than assets. They recommend cost optimisation, digital transformation and smarter asset use – just what a Dean wants to hear! One of their key actions is 'Accelerate digital transformation to enhance student outcomes, efficiency and competitiveness'. This strong business perspective needs to be balanced with the requirements for quality education and research.
